Recommendation:

Staff recommends affirming the City's commitment to the principles of a Dementia Friendly Community which include a commitment to equity, inclusion, access and awareness for those affected by dementia and our desire to provide them with a supportive, welcoming and informed community in which to live and visit. The attached Resolution will assist our efforts at becoming formally recognized as a Dementia Friendly Community by Dementia Friendly America (DFA).

Background:

The number of people living with dementia is increasing as a result of population aging. Impairments related to neurological changes, together with environmental challenges, result in disability for people who have dementia. DFA is a national network of communities, organizations and individuals seeking to ensure that communities across the U.S. are equipped to support people living with dementia and their caregivers. Dementia friendly communities foster the ability of people living with dementia to remain in community and engage and thrive in day to day living. A Dementia Friendly Community is a village, town, city or county that is informed, safe and respectful of individuals with the disease, their families and caregivers and provides supportive options that foster quality of life. Joining DFA means a community is engaging in a process to become more dementia friendly.
